Excused dates are outlined in the 2023 OVFM Market Rules. Unexcused Absences and No-Shows will not be refunded.

**Registered Non-Profits:**

The fee for Non-profit organizations selling products or fundraising is \$50 for the full season. For Non-profit organizations that do not sell, and are "information only", the fee is \$25 for the full season.

**In 2023, Vendor carried liability Insurance will be required for ALL Vendors.**

**Insurance Requirements** – All vendors, except Co-Op Vendors, must carry and provide a copy of their Liability insurance policy to the Market Manager. Vendor policies must have a \$1,000,000 Each Occurrence, a \$1,000,000 Products – Completed Operations Aggregate and a \$1,000,000 General Aggregate minimum limit. All policies shall be written on a Per Occurrence basis. The Vendor shall be named as the insured on the policy and the **City of Orting P.O. Box 489 Orting Washington 98360, the WSFMA (Washington State Farmers Market Association) 93 Pike Street, Suite 316 Seattle Washington, 98101, and the Orting Valley Farmers Market, its officers, directors, agents, employees and event sponsors P.O. Box 1665 Orting Washington 98360**, shall be named as additional insured thereon. Your vendor coverage insurance agency must include these named additional insureds on your Policy document.

Vendor Liability Policies can be obtained online or with many carriers handling homeowners, renters, and auto policies. Please list your policy below and provide a copy of your Vendor Insurance Policy with this application. All Vendors must provide a copy of their coverage by their first OVFM Market Day, in order to attend OVFM. A Homeowners insurance policy does not cover Farmers Market Vendor Liabilities unless specifically written that way.
